BACKGROUND TO THE PROPOSED PROGRAMME

The aim of the programme is to enable the learner with the knowledge, skills and competence to perform the role of Chief Mate in a management capacity on board ships of greater than 3000 Gross tonnage trading worldwide as stipulated in the Seafarers Certification and Watchkeeping (STCW) Code, Table A-II/2.



FINDINGS OF THE PANEL
