## BACKGROUND TO THE PROPOSED PROGRAMME

The proposed programme is a 4-year ab-initio Bachelor of Arts (Honours) in Photography with New Media. This programme is jointly proposed by the Department of Fine Art & Applied Art and the Department of Media Communication in the CIT Crawford School of Art & Design. It was originally proposed under the title of *Bachelor of Arts (Honours) in Photography & Video*. This was revised to the present title on foot of a panel requirement (see Requirement 1.2).

The programme will be hosted by the Department of Fine Art & Applied Art, and a first intake is planned for September 2018. The programme is to be offered in F-T and ACCS modes.

The BA (Hons) in Photography with New Media seeks to build on CCAD's long photography and video tradition to offer a programme with a professional photography and video focus, which is not currently provided by any other higher education institution outside of Dublin.

The proposed degree will have a professional emphasis. Its overall aim will be to produce graduates who will be able to work with historical, contemporary and emerging photography and moving image technologies in a wide variety of professional settings. The programme will provide students with the essential knowledge and skills, both creative and technical, required for a career as a professional photographer and/or videographer. It will also offer a learning pathway for Fine Art students where appropriate.

The core curriculum covers three broad strands: Contextual (historical, theoretical and professional knowledge); Practical (technical and creative skills) and Professional (work-related, including work-based, competence and career-planning knowledge and skills).

The programme proposes to utilise a number of existing modules along with established resources and existing staff expertise as a strong foundation on which to build and deliver its proposed content. It is envisaged that existing staff expertise will be significantly augmented by guest lecturers who are nationally and internationally renowned experts in photography and moving image production.

Currently the only degree course in photography that has a distinct focus on professional or commercial practice is offered by Griffith College, Dublin, and this is offered only as a Level 7 programme. While DIT, NCAD, IADT and LIT all offer courses in photography, these are broad-based programmes growing out of an art or fine art base. The BA (Hons) in Photography with New Media would be unique in Ireland in offering a Level 8 qualification explicitly in professional/commercial photography and moving image production; in including a 30-credit work placement in Stage 3; and in offering formalised international opportunities either for study or work placement abroad.

While no exit award is proposed for this programme at this point, future development of a Level 7 exit award is under consideration.



## Findings of the Panel

*NOTE: In this report, the term "Requirement" is used to indicate an action or amendment which in the view of the Panel must be undertaken prior to commencement of the programme, as a condition of validation.* 

The term "**Recommendation**" indicates an item to which the Institute, academic unit or programme board should give serious consideration. Normally it is expected that recommendations will be implemented as soon as possible. Progress will be the subject of ongoing monitoring and will be discussed in programme review.

Requirements and recommendations may be accompanied by a <u>short</u> summary of the findings giving rise to them. Panels may also record other findings (including on commendable features of the proposed programme) which they deem important for the quality assurance record.

The Panel has considered the documentation provided and has discussed the programme with the proposers. Based on this, the Panel has arrived at a number of Findings, Requirements and Recommendations as follows.

## **1. Programme-Level Findings**

## 1.1 NEED FOR THE PROGRAMME

Validation Criterion: Is there a convincing need for the programme with a viable level of applications?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

Regarding viability, also note Validation Criterion 1.6.

The Panel heard that the proposed intake for the programme is 20 entrants annually. This target can likely be met from the pool of potential entrants outlined in the documentation and in discussion.

Outside of Dublin, no other photography degree with a clear commercial / professional focus is currently on offer in Ireland. The new degree will offer a welcome progression route to a Level 8 qualification particularly for learners in the Munster area interested in a professional photography-related career.

**1.1.1 Commendation:** The Panel considers that this programme will fill a gap in the market, and will vastly enhance and increase the pool of qualified applicants for positions offered by professional photography businesses in the region. New entrants to the field of commercial photography require a broad knowledge base and a wide spectrum of abilities, and this programme will provide that. The team is therefore commended for submitting this proposal.

The Panel however noted that a recent survey on demand (pp. 9-10 of the submission) showed a higher preference for part-time delivery, while the programme is proposed for full-time delivery. Study in ACCS mode will be available.

**1.1.1 Recommendation:** The Panel recommends that a part-time delivery route for the programme should be investigated down the road, in order to maximise the possibilities for entry.



## 1.2 AWARD

## Validation Criterion: Are the level and type of the proposed award appropriate?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

The programme proposal was submitted to the Panel with the title of \**Bachelor of Arts (Honours) in Photography and Video*. The Panel heard that there had been debate around the programme and award title. The proposers wanted to ensure that entrants understand from the outset that the programme aims to prepare for professional practice in the production of both still and moving image. However, the technical term 'moving image' may not be understood as well as 'video' by potential applicants. The Panel queried whether the programme includes as much content on video/moving image practices as it does on still photography. The team outlined that project-based work in particular will allow learners to develop their own specialised practice around either. The Panel notes these considerations. However, it has concerns that the term 'video' is beginning to date within the discipline and the professional community, and does not make the most of opportunities to show the clear linkages with other cognate programmes within the CCAD programme portfolio.

**1.2.1 REQUIREMENT:** The Panel requires that the proposers revisit the programme and award title to better reflect the existing disciplinary community within the Crawford College, and to achieve a better match with the intended the professional profile and expectations. The goal should be to ensure that the programme/award title 'talks' both to applicants and to potential employers and industry. As a suggestion only, the inclusion of "Digital Media" in the title could be considered, which would also align the programme with related offerings of the Department of Media Communications.

The Panel also observed that the Programme Outcomes submitted do not fully represent the spectrum of intended knowledge, skills and competences which is very well expressed in the departmental submission.

**1.2.2 REQUIREMENT:** The Programme Outcomes should therefore be revisited and clarified. In particular, they should reflect the full spectrum of technical competences and applied craft/practical skills to be acquired and should fully match the aims and objectives for the programme in the departmental submission.

## **1.3 LEARNING EXPERIENCE**

Validation Criterion: Is the learning experience of an appropriate level, standard and quality overall?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

The proposed Programme Outcomes are attached as Appendix 1. Findings, requirements and recommendations concerning individual modules are recorded in Section 2 below.

An overall Assessment Schedule not included with the programme documents submitted to the Panel was submitted to the Registrar's Office subsequent to the site visit. The Panel has made no findings or recommendations with regard to assessment.

The programme team outlined the proposed arrangements for internationalising the learner experience throught the New European Forum for Photography initiative jointly developed by CIT and several other Universities of Applied Sciences across the European HE area.



**1.3.1 Commendation:** The Panel commends the programme team for the conception and implementation of this exceptional mechanism for embedding an international experience into the proposed programme.

The Panel heard that CIT has some excellent teaching & learning offerings in the online space, amongst others with regard to the development of e-portfolios, supported by a dedicated Department of Technology-Enhanced Learning.

**1.3.2 Recommendation:** The team should consider integrating and mapping some of the existing online offerings into the delivery of this programme. The development of online portfolios to an international standard would merit particular attention.

## **1.4 PROGRAMME STRUCTURE**

Validation Criterion: Is the programme structure logical and well designed (including procedures for access, transfer and progression)?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

The Semester Schedules as proposed are in Appendix 2.

A visual mapping of the sequence of mandatory modules throughout the semesters along the three core programme strands as introduced in the programme submission – contextual, practical and professional – was tabled by the proposers during the meeting.

**1.4.1 Commendation:** The Panel commends the team on the mapping, as the visualisation immediately clarifies the intended progression through the core modules in the different programme strands.

**1.4.2 Recommendation:** Building on this initial mapping, the proposers should consider reviewing the sequence of mandatory modules to satisfy themselves that their sequence is designed around the student journey and progression along the three strands of theory (context), practice and professional skills.

**1.4.3 Recommendation:** As a next step, the team is asked to also review the mapping of the cognate electives against the through-lines and progression in the core strands, to ensure that they are in the right order.

**1.4.4 Recommendation:** In future, once the viability of the programme is established the programme team could consider the development of bespoke electives e.g. on professional or business-related subject matter.

With regard to the professional skills stream, the new draft modules *Professional Identiy* and *Photography, Law & Ethics* (Stage 4 Sem. 1) in particular merit a review of their structure and the distribution of their content. In the panel's view, these modules are not sufficiently distinct and seem to artificially split a continuum of content and skills development.

**1.4.5 Recommendation:** The modules in the professional skills stream throughout the programme should be reviewed in terms of content, structure and sequencing.

In this context, the team should consider if amalgamating *Professional Identity* and *Photography, Law & Ethics* into a 10-credit module might enable better and more integrated professional skills development, and might prepare learners more effectively for independent practice. Any such amalgamation will need to be



cognisant of CIT policy with regard to large credit modules and the effect on the learning experience in Semester 1 of Stage 4.

**1.4.6 Recommendation:** In addition, the module learning outcomes and assessment formats throughout the professional skills stream should be reviewed to ensure they appropriately reflect, and test, the learners' practical skills acquired throughout the module, rather than their ability to discuss the necessary skills.

## 1.5 PROGRAMME MANAGEMENT

#### Validation Criterion: Are the programme management structures adequate?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

The Panel observes that the programme submission includes a departmental philosophy and mission statement for one, but not the other of the departments involved in delivery.

**1.5.1 Recommendation**: The Departments of Fine Art & Applied Art and of Media Communications are asked to draw up a cross-departmental mission statement and philosophy for this programme which presents the specific programme ethos, philosophy and mission. The aim would be to showcase the unique features of this cross-departmental programme and to support the building of a community of delivery and learning. The programme mission should be made available to learners in the programme guidance provided to them in all appropriate formats and locations.

#### 1.6 **RESOURCE REQUIREMENTS**

Validation Criterion: Are the resource requirements reasonable?

Overall Finding: Yes, subject to certain Requirements and/or Recommendations.

In addition to the list of available equipment in the documentation, the programme team gave an overview of current photographic and IT equipment in the Crawford College and the Department of Media Communications in Bishopstown during the panel meeting. The Head of College indicated that two bids had gone to the Institute Executive to upgrade/replace existing outdated equipment and to purchase new equipment which could also be used by students on the proposed degree. The panel also surveyed the equipment at the Sharman Crawford Street site during a brief tour of facilities.

There was agreement that the current equipment, without the injection of a significant portion at least of the resources applied for, does not permit the proposed programme to be delivered to an adequate, industry-relevant standard. In stating this, the panel is cognisant of the continuing strain on Institute resources. This may suggest some lateral thinking in how, for certain purposes at least, ongoing access to up-to-date equipment might be secured with the help of industry by means other than purchase.

**1.6.1 REQUIREMENT:** Due to its concerns around resources, specifically equipment, the Panel **requires** that the proposers draw up and agree with the Faculty a 5-year plan of the investment to support the resourcing of the programme. This plan should be drawn up in consultation with industry – e.g. through the planned industry advisory group – and should factor in any available industry supports. The agreed plan should be submitted to the Panel so that it can ascertain itself that the programme can indeed run.



In addition to showing how the initial investment required to 'get the programme off the ground' can be secured, the plan should also evaluate and confirm the long-term sustainability of the resourcing – again, in particular the equipment – in partnership with industry.

## 1.7 IMPACT ON THE INSTITUTE

#### Validation Criterion: Will the impact of the programme on the Institute be positive?

Overall Finding: Yes, but note the findings on resources under Validation Criterion 1.6.

## 2. Module-Level Findings

The Panel notes that 18 modules on the proposed programme are pre-approved modules which may be delivered across several CIT programmes.

The Panel was informed that a sample of the new draft modules had been the subject of preliminary internal desk review, but that the new draft modules had not been comprehensively moderated.

In exercising its brief to consider the overall standard and appropriateness of modules, the Panel wishes to add the following findings, requirements and recommendations.

## 2.1 ALL MODULES

**REQUIREMENT:** Any revisions to Module Descriptors or Semester Schedules made to address the recommendations and requirements in this require sign-off from the CIT Module Moderator and the Registrar's Office prior to approval by the CIT Academic Council.

## 2.2. Module: Visual Culture (Advanced, 10 Credits, Stage 4 Sem. 1)

Whilst not immediately obvious from the title, this module constitutes the academic dissertation module on the programme. In the Panel's opinion there is a significant amount of content and learning condensed into 10 credits, which is in addition to the work associated with the major 30-credit project in Stage 4 Sem. 2. The Panel heard that the expected word count would be in the range of 6,000 – 8,000 words.

**2.2.1 Recommendation:** The module should be reviewed, with a view to providing alternative options for written work to the standard academic research dissertation. This could be a major piece of writing to prepare for and complement the portfolio project to be carried out during the subsequent semester, for instance, or it could be written work expanding on the professional and business skills aspects of the programme.

**2.2.2 Recommendation:** The title of the module should be revised to better signify the nature of the content and the nature of the work to be carried out.



## 3. Conclusion

Based on the above findings, the Panel has arrived at the following Conclusions:

- The Programme meets the required standards for an award in its field of study at Level 8 of the National Framework of Qualifications.
- The Programme meets the criteria for validation of a new programme adopted by the Academic Council of Cork Institute of Technology.

The Panel therefore recommends that the Programme be validated for five academic years, or until the next programmatic review, whichever is soonest, subject to implementation of the Requirements above, and with due regard to the Recommendations made.
