# **Biopharmaceutical** Manufacturing Operations

Cork Institute of Technology offers a number of springboard courses in Biopharmaceutical Manufacturing Operations: a Higher Certificate (Level 6) and a Diploma Certificate (Level 7). These programmes are available for individuals who are seeking to up-skill or cross-skill in order to gain sustainable employment in sectors such as Biopharmaceutical, Pharmaceutical and Medical Device industries. The students undertaking these courses gain practical skills and knowledge pertinent to working within these highly regulated fields. Topics covered includes GMP, Quality, Validation Science, Lean Manufacturing, Process Transfer, Upstream and Downstream Processing. Integral elements of these one year programmes are that the students undertake a work placement and also, a two day training course in the National Institute for Bioprocessing Research and Training (NIBRT).
